In addition to all these events, we now are proud to display our new ISACA logo. To convey its broadened scope of professional expertise, the Information Systems Audit and Control Association will use only its acronym—ISACA—after 1 January 2006. The association has also adopted a new tagline to further define and explain its acronym: ISACA: Serving IT Governance Professionals.

"ISACA is changing its logo to reflect the expanded professional

niche we serve. We have seen an increasing number of information security professionals in our membership, and we are committed to providing pertinent programming and research to our constituents," said Everett Johnson, CPA, international president of ISACA. "In addition, we find that our members are eager for information on IT governance, privacy, control, risk management and the entire gamut of IT control and governance-related activities."

ISACA remains committed to serving the fields of assurance and control, which, along with information security, are included under the broader, encompassing umbrella of IT governance.

"We realized that all of the professions we serve fall under the IT governance banner," said Johnson. "Each one of those professions has an important role to play in ensuring that organizations exercise effective governance."

As in past years, many activities have been scheduled for this coming year. I have highlighted some of the key events below and I hope that you will take the opportunity to participate in these events and better yet, to volunteer your time by helping out the various committees:

PRESIDENT'S MESSAGE - CONTINUED

SAN FRANCISCO ISACA FALL CONFERENCE -

Save the dates of September 25 – 27, 2006. This coming year's fall conference will be again held at the Nikko Hotel. Based on the 2005 fall conference results, we fully expect to exceed last year's attendance replete of educational sessions for all participants. Needless to say, this is our most prestigious annual event, so stay tune for upcoming announcements. Feel free to contact any of the board members, officers or committee chairs if you wish to participate or volunteer your time. No time is too small in making this yet a more memorable event.

BEST PAPER CONTEST FOR STUDENTS -

We are offering another exciting year for the best student paper contest. If you have a talent for writing and have an IT security or audit topic that you would like to write about, this is the perfect opportunity for you. Entry submission deadline will be announced in the coming months.

CISA AND CISM REVIEW COURSES -

The SF chapter is offering another year of CISA and CISM review courses. This year we had a June CISA and CISM examination but also for the first time a December 2005 examination. The CISA and CISM courses for both examinations in June and December had record attendance such that our classrooms were at capacity. The December exam administration closed with more than 13,500 CISA

and 1,300 CISM registrants worldwide. The chapter in June had 79 CISA and 7 CISM exam passers that were members of our chapter. This was the last exam that will use the current CISA job practice areas and the 2005 CISA study materials. The study materials and registration for June 10, 2006 CISA and CISM exams are now available. Early registration for both exams is February 8, 2006 with a deadline registration date of April 5, 2006. The SF ISACA Chapter will again be providing exam review courses in 2006.

MONTHLY EDUCATION EVENTS -

The SF Chapter continues to offer monthly education events for our chapter members. Due to the success of these monthly events, as well as the fall conference, we will continue to subsidize the events by keeping the cost of the monthly educational meetings and the conference at the same price. In addition to our luncheon events, we will again offer two full day sessions this year. On February 16, we will offer a full day course on "Auditing Outsourced Operations" at a low \$110 registration fee for members of ISACA and IIA taught by the MIS Training Institute (MISTI). On May 18, there will be four concurrent full day sessions that will also be offered at a nominal price. Our belief is that the chapter's goal is to provide high quality educational opportunities in giving back to our membership. Stay tuned for more details on our upcoming events.

WEB SITE REVAMP PROJECT -
We have had some delays

in revamping our Web site. However, with the holidays behind us, our goal is to complete this project by the 2nd quarter of 2006. We are working hard on improving the Web site so that our information about chapter activities current and useful to our members. Our chapter also continues to experience phenomenal growth. As of this writing, we have 775 members. This represents a growth of 38% (563 members) in 2004 and 84% (421 members) in 2003. As you can see, we have a busy year ahead of us. The Board, its chairs and volunteers are here to serve you. 

COBIT 4 Announcement

IT Governance Institute is extremely pleased to announce the release of a new key component of its IT governance library: COBIT 4.0.

COBIT 4.0 is the first update of the COBIT content since COBIT 3rd Edition was released in 2000. This new version reflects increased harmonization with other detailed standards, greater emphasis on IT governance, streamlining of concepts and language, and detailed analysis of metrics concepts, among other improvements. The new volume, consisting of more than 200 pages, includes an executive overview, the framework, the core content (high-level control objective, detailed control objectives, management guidelines and maturity model) for each of the 34 processes, and several appendices.

COBIT 4.0 represents the efforts of literally hundreds of volunteer experts from around the world. It is available for free download from www.itgi.org, and for purchase from the ISACA Bookstore, www.isaca.org/cobit.

CISA Certification

The CISA program is designed to assess and certify individuals in the IS audit, control and security profession who demonstrate exceptional skill and judgment. CISA has grown to be globally recognized and adopted worldwide as a symbol of achievement. The CISA certification has been earned by more than 35,000 professionals since inception. As Sarbanes-Oxley Act becomes effective in the United States, the value of CISA has increased dramatically due to the increasing demand for IS audit skills and knowledge in external audits, internal audits and IT governance. The CISA Exam and CISA Review Course

The CISA exam is one of the requirements to become a CISA. It is offered each year in June and consists of 200 multiple-choice questions, administered during a four-hour session in multiple locations (e.g. San Francisco and San Jose in the Bay Area). The purpose of the exam is to test a candidate's knowledge, evaluation and application of IS audit principles and practices and technical content areas. The San Francisco Chapter of ISACA is pleased to announce that it is offering a unique opportunity to prepare for the Certified Information Security Manager exam. The CISM certification has been specifically developed for the informational security professional and defines the core competencies and international standards of performance that information security managers are expected to master.

This weekend workshop provides an excellent opportunity to clarify the thought processes when working under pressure and ensure that candidates have the required experience and knowledge in information security management to take the examination. Therefore attendees are expected to have knowledge of all the CISM domains. The format is primarily a reminder of the tasks and knowledge requirements for each CISM domain, followed by a mock examination. Some time is also allocated for examining the structure of a CISM question and discussing a generic approach to help identify the appropriate answer. This not only hones the candidates' examination technique, but also provides for lively discussion.

The workshop will begin at 12:30 PM on Friday, May 19, 2006. There will be a four hour session that Friday afternoon followed by an eight hour session on Saturday, May 20th and a four hour session on the morning of Sunday, May 21st. The location will be the Deloitte office in San Francisco at 50 Fremont Street. We are limiting the number of attendees at the class in order to provide a high-quality learning experience. Lunch for May 20th and refreshments will be provided.

Friday Afternoon (4 Hours)

Introductions and course outline – set the expectations for the weekend workshop.

Information Security Governance
– Establish and maintain a framework to provide assurance that information security strategies are aligned with business objectives and consistent with applicable laws and regulations. The objective of this core competency, which accounts for 21% of the exam content, is to focus on the need for a stable security program.

Risk Management – Identify and manage information security risks to achieve business objectives. This topic area is included to test the applicant's knowledge in the area of risk identification and management as they relate to business needs. This area accounts for 21% of the exam contents.

Saturday (8 Hours)

Information Security Program Management
– Oversee the internal and external resources for information security are identified, appropriated and managed. Candidates will have to show proficiency in their understanding of the tools required to manage an information security program. The topic area accounts for 21% of the examination total.

Response Management – Develop and manage a capability to respond to and recover from disruptive and destructive information security events. This section addresses the need for development and implementation of policies and procedures and accounts for 13% of the exam total.

Sunday Morning (4 Hours)

Information Security Management
– Design, develop and manage an information security program to implement the information security governance framework. The topic area stresses the skills and knowledge necessary to create and implement the information security framework. This section accounts for 24% of the examination material.

Exam Overview and Drill– This section will review the requirements to sit for the CISM exam and how to maintain the certification after successful completion of the examination process. We will provide the attendees with techniques used by other successful certification candidates, and with tips on how to study and how to prepare for an exam. We will also take a sample exam.

CISA ITEM WRITING PROGRAM

In order to continue to offer an examination that measures a candidate's knowledge of current audit, security and control practices, new questions are regularly required for the CISA Examination. Questions are sought from experienced practitioners who can develop items that relate to the application of sound audit principles and practices.
