Cybercriminals generally take the path of least resistance, and they've learned that contractors and other third-party providers can provide an opening into otherwise-secured corporate networks. We have seen major data breaches at retailers like Target and Home Depot occurred because attackers were able to obtain valid network credentials from trusted, third-party providers. Basically, the back door was wide opened and they just walk right in. This panel discussion will focus on what you need

to do to build out a Vendor Risk Program and how to assess vendor risk. Experts from regulated industries (healthcare and financial) and companies in Silicon Valley, who are heavily dependent on vendors, will discuss best practices to address third party vendors risks.
